STEPS IN CANADA VISA PROCESSING

1. Please read and sign our [Data Privacy Agreement](#) then email it together with the accomplished [questionnaire](#) and the scanned copy of Passport's bio page for Free Assessment (we will advise the chances of approval)
2. After the assessment and should you wish to proceed with the application, pay the visa assistance fee then email the proof of payment together with all the requirements (soft copy only)
NOTE: Please provide everything that you can because this is the hardest visa to apply for.
3. We will forward the application to the Canada Embassy. Once forwarded, we'll wait for the embassy to send the Biometric Request then we'll schedule your biometric appointment.
4. Make sure to bring the Biometric Request and Appointment Letter on your biometric appointment together with your valid passport for identification.
5. Once done with the Biometrics, we will wait for the result which is up to 25 working days. Once approved, your passport must be submitted to the embassy for finalization of the Visa. You may personally submit your passport to any of our offices or through a courier.
6. Upon submission of your Passport, it'll take 5 to 7 working days before it will be released with the Visa. We will notify you once your passport with Canada Visa is ready to be claimed at our office EGJ Travel Services.
