#### STEPS IN SCHENGEN VISA PROCESSING (with PERSONAL APPEARANCE for biometrics)

- 1. Email Accomplished Questionnaire and Scanned Copy of Passport for Free Assessment (we will advise the chances of approval)
- 2. Pay the visa assistance fee, email the proof of payment and your preferred schedule of appearance
- 3. We will encode your application form and once done, we will schedule your appointment at the Visa Application Center.
- 4. Prepare the documents needed for the appearance, make sure everything is printed and complete because the Visa Application Center will not accept incomplete applications. It's best to show us the requirements so we can double check everything before your scheduled appearance. If not, a soft copy is okay.

5. Pay the VISA Fee on the scheduled appointment at the Visa Application Center.

After the biometrics, you can also avail the passport delivery service if you are outside Metro Manila. No need to avail the text service since communication is through email.

- 4. Visa submission is within 3 working days after the receipt of complete documents and if there are no additional requirements needed. We strongly suggest applying at least 1 month prior to the planned travel date because there are times where the visa officer is requesting for additional documents.
- 5. For a denied application, you can reapply after 6 months. No Refunds for the Visa Assistance fee.
